Dear City Residents and Businesses,

City of Lima is providing you with the opportunity to participate in the City's Electric Governmental Aggregation Program. Savings are possible through a concept called government aggregation, where City council bring together citizens to gain group-buying power for the purchase of Electric from a retail supplier. Both the City and supplier are certified by the Public Utilities Commissions of Ohio. City voters approved this program in May 2023. The aggregation program for City of Lima will begin within one to two billing periods following your inclusion as a participant in the City's program and end with your May 2025 meter reading. As an eligible resident or small business, you will be automatically enrolled in the program unless you choose to opt-out (not participate) by **August 11, 2023**.

During the past few months, we have researched options for competitive electric pricing for you. City of Lima is pleased to announce it has selected Dynegy as the preferred electricity supplier for its program.

Program Details:

- **Fixed Electricity Price** of \$0.06280 per kWh through your May 2025 meter reading. Or choose 100% renewable energy for \$0.06610 per kWh. Please call us for this option.
- **One energy bill** from AEP Ohio, your local utility provider.
- **No Fee** to cancel at any time.
- By receiving this letter, you **do not need to do anything** to be a part of the program.
- AEP Ohio continues to deliver your electricity and maintain the electric lines and respond to emergencies.

Program Enrollment

After your enrollment is finalized, AEP Ohio will send you a letter confirming your enrollment. As required by law, this letter will inform you of your ability to rescind your enrollment with no penalty.

How to Opt-Out

If you do not wish to participate, you must opt-out no later than **August 11, 2023**. You can do this by completing and returning the reply card below or by calling 888-682-2170.

If you choose to opt out (not participate), you may do so at no charge during this initial enrollment period and you will not be served by Dynegy. If you become part of the aggregation, you may cancel the agreement at any time at no charge by providing notice to Dynegy. If you choose to opt out of the program at this time, or if you choose to leave the program at a later date, you will be served by your utility under its standard service offer or until you choose an alternative supplier. If you switch back to your utility, you may not be served under the same rates, terms, and conditions that apply to other customers served by your utility.
