Dear Clearcreek Township Residents and Businesses,

Clearcreek Township is excited to offer you an opportunity to participate in an Electric Governmental Aggregation Program. Township voters authorized the Township Trustees to form a governmental aggregation program and negotiate favorable electric supply prices for eligible residences and businesses. The Township recently selected Dynegy Energy Services (DES) as the program supplier through your August 2019 applicable meter reads. Both Clearcreek Township and Dynegy Energy Services are certified by the Public Utilities Commission to provide this service. As an eligible resident or small business, you will be automatically enrolled in the program unless you choose to opt-out (not participate) by July 18, 2016.

If you do not opt-out, your service should begin no later than your August 2016 meter read. Here are the highlights of the offer: **Electricity Price** of \$0.0539 per kWh through your August 2019 meter reading.

- Provides **security** against electricity price fluctuations.
- One energy bill from your local electric utility (either Duke Energy Ohio or Dayton Power & Light).
- By receiving this letter, you do not need to do anything to be a part of the program

Billing / Service Delivery Unchanged

Other than the price and supplier, nothing regarding your electric service will change. You will continue to receive one monthly bill from your electric utility. The electric utility will continue to deliver your electricity and be responsible for maintaining the system that delivers electricity to your home.

Enrollment Information

After your finalized enrollment, your electric utility will send you a letter confirming your enrollment. As required by law, this letter will inform you of your ability to rescind your enrollment with no penalty.

If you choose to opt out (not participate), you may do so at no charge during this initial enrollment period and you will not be served by Dynegy Energy Services. If you become part of the aggregation, you may cancel the agreement at any time at no charge by providing notice to Dynegy Energy Services. If you choose to opt out of the program at this time, or if you choose to leave the program at a later date, you will be served by your utility under its standard service offer or until you choose an alternative supplier of electric service. If you switch back to your utility, you may not be served under the same rates, terms, and conditions that apply to other customers served by your utility.
