Dear Deer Park Residents and Businesses,

Welcome to the City of Deer Park's NEW Electric Government Aggregation Program. In November 2012, the voters authorized the City's Officials to form a governmental aggregation program and negotiate favorable electric supply prices and terms for eligible residences and businesses. Since 2013, the City and Dynegy have partnered to implement a very successful electric aggregation program that offered a favorable price and term. The City has again selected Dynegy for a new electric aggregation program through your December 2020 meter read. Both the City of Deer Park and Dynegy are certified by the Public Utilities Commission to provide this service. As an eligible resident or small business, you will be automatically enrolled in the program unless you choose to opt-out (not participate) by **October 31, 2017**.

## **Program details:**

- o Fixed Electricity Price of 5.69¢ per kWh through your December 2020 meter reading
- **One energy bill** from Duke Energy, your local utility.
- No cancelation fee at any time!
- o Duke Energy continues to deliver your electricity and maintain the electric lines and respond to emergencies.

# **Program Enrollment**

After your enrollment is finalized, Duke Energy will send you a letter confirming your enrollment and informing you of your ability to cancel your enrollment with no penalty.

#### How to Opt-Out

If you do not wish to participate, you must opt-out no later than **October 31, 2017**. You can do this by completing and returning the reply card below or calling us toll-free at 888-682-2170.

If you choose to opt out (not participate), you may do so at no charge during this initial enrollment period and you will not be served by Dynegy. If you become part of the aggregation, you may cancel the agreement at any time at no charge by providing notice to Dynegy. If you choose to opt out of the program at this time, or if you choose to leave the program at a later date, you will be served by your utility under its standard service offer or until you choose an alternative supplier of electric service. If you switch back to your utility, you may not be served under the same rates, terms, and conditions that apply to other customers served by your utility.
