Dear Green Township Residents and Businesses,

Green Township is offering you an opportunity to participate in an Electric Governmental Aggregation Program. Green Township voters previously authorized the Township to form a governmental aggregation program and negotiate favorable electric supply prices for eligible residences and businesses. The Township selected Dynegy as the program supplier through your May 2020 meter read. Both the Township and Dynegy are certified by the Public Utilities Commission to provide this service. As an eligible resident or small business, you will be automatically enrolled in the program unless you choose to opt-out (not participate) by **April 17, 2017**.

## Program details:

- o Fixed Electricity Price of 5.39¢ per kWh through your May 2020 meter reading.
- No cancelation fee at any time!

- No changes in your billing; you will receive one bill from Duke Energy and they will continue to deliver your electricity and maintain the electric lines and respond to emergencies.
- **Green Energy Option Available**: Uses 100% Renewable Energy 5.49¢/kWh through your May 2020 meter reading. *Note for the green price, you'll need to call Dynegy (888-682-2170) to enroll in this option.*

## **Program Enrollment**

After your enrollment is finalized, Duke Energy will send you a letter confirming your enrollment and informing you of your ability to cancel your enrollment with no penalty.

If you do not wish to participate, you must opt-out no later than **April 17, 2017**. You can do this by completing and returning the reply card below or calling us toll-free at *888-682-2170*.

If you choose to opt out (not participate), you may do so at no charge during this initial enrollment period and you will not be served by Dynegy. If you become part of the aggregation, you may cancel the agreement at any time at no charge by providing notice to Dynegy. If you choose to opt out of the program at this time, or if you choose to leave the program at a later date, you will be served by your utility under its standard service offer or until you choose an alternative supplier of electric service. If you switch back to your utility, you may not be served under the same rates, terms, and conditions that apply to other customers served by your utility.
