Dear Richland Township Residents and Businesses,

Richland Township and Dynegy are excited to offer you an opportunity to participate in an Electric Governmental Aggregation Program.

Under governmental aggregation, the Richland Township Trustees act on behalf of electric consumers in Richland Township to negotiate an electric supply contract with an eligible provider. Both Richland Township and eligible retail electric suppliers have to be certified by the Public Utilities Commission of Ohio. Richland Township Trustees passed a resolution to adopt the program after Richland Township voters approved its implementation on November 8, 2016. The aggregation program for Richland Township will begin within one to two billing periods following your inclusion as a participant in the Township's program and end with your May 2020 meter reading. As an eligible resident or small business, you will be automatically enrolled in the program unless you choose to opt-out (not participate) by **November 19, 2018**.

Program Details:

- Fixed Electricity Price of 5.46¢ per kWh through your May 2020 meter reading.
- One energy bill from AEP Ohio, your local utility provider.
- No Fee to cancel at any time.
- By receiving this letter, you do not need to do anything to be a part of the program.
- AEP Ohio continues to deliver your electricity and maintain the electric lines and respond to emergencies.

Program Enrollment

After your enrollment is finalized, AEP Ohio will send you a letter confirming your enrollment. As required by law, this letter will inform you of your ability to rescind your enrollment with no penalty.

How to Opt-Out

If you do not wish to participate, you must opt-out no later than **November 19, 2018**. You can do this by completing and returning the reply card below or by calling 888-682-2170.

If you choose to opt out (not participate), you may do so at no charge during this initial enrollment period and you will not be served by Dynegy. If you become part of the aggregation, you may cancel the agreement at any time at no charge by providing notice to Dynegy. If you choose to opt out of the program at this time, or if you choose to leave the program at a later date, you will be served by your utility under its standard service offer or until you choose an alternative supplier of electric service. If you switch back to your utility, you may not be served under the same rates, terms, and conditions that apply to other customers served by your utility.
